The SACC PI provides the student with the critical legal foundation as legislated by SARS: Customs. First presented in 1997, this course provides the highly sought after SDS1® required by F&C industry employers.

### Upon completion of this course, learners can:

- Communicate with Customs and colleagues using legal terms, abbreviations and definitions
- Solve legal challenges by looking up legislation in the Customs Control and Duty Acts 2014
- Identify the most frequently used Customs forms, documents and declarations (bills of entry) according to their use and customs procedure
- Distinguish between various transport documents according to their use and purpose and identify and complete the applicable fields on the SAD500 declaration
- Report on minor problems encountered in Customs releases
- Comply with organization ethics
- Entrance to this course is available to all candidates who have functional literacy and numeracy to Grade 10.

### Duration:

**Part Time:** 7 weeks, Lectures Every Saturday 08h00 to 13h00, 4 Lectures and 2 Examinations, 1 Week Study Break before Examinations. **Investment:** R8 050 (Excl. VAT)
