## Why this course?

Exporting goods and services can be a very lucrative venture. In order to export efficiently from South Africa, it is important for individuals to understand the legal requirements, processes and procedures of the export environment. The SA Export Compliance course provides the student with the key skills required to function in the Customs Brokerage export environment and is also suited to those who function in an export company.

### Upon completion of this course, learners can:

- Classify commodities using the rules for the interpretation of the Harmonised Commodity Coding and Description System (Tariff)
- Display an understanding and apply the legal requirements of the Customs Act as this applies to exports
- Interpret and apply INCOTERMS® 2010
- Calculate export value for singular and multi-line declarations by applying factorisation formulae
- Produce comprehensive worksheets for Customs export declarations (SAD 500)
- Frame singular and multi-line clearance declarations (SAD 500)
- Apply the principles and procedures pertaining to prohibited and restricted exports
- Prepare exports for shipment
- Display knowledge and understanding of refund and drawback claims
- Perform processes and procedures required for the administration of export transactions
- Display knowledge and understanding of transport documentation applicable to the export environment
